Position Statement

I believe my eclectic background and wide-ranging experiences will be a real asset to the USITT Board of Directors. In my early career stages, like many technical theater graduates, I held down many different jobs to support myself before landing steady employment in high school and university theatre programs. After leaving academia in 2014, I worked on a corporate event at the local convention center, which was a true revelation.
